A new Section, Section C, was added to stipulate that Chapter Chairpersons are now to be elected in even-numbered years at a chapter meeting in January, February, or March (proposed Bylaws Article IV, Section C).	The current Constitution does not stipulate when or how often Chapter Chairpersons are elected.
